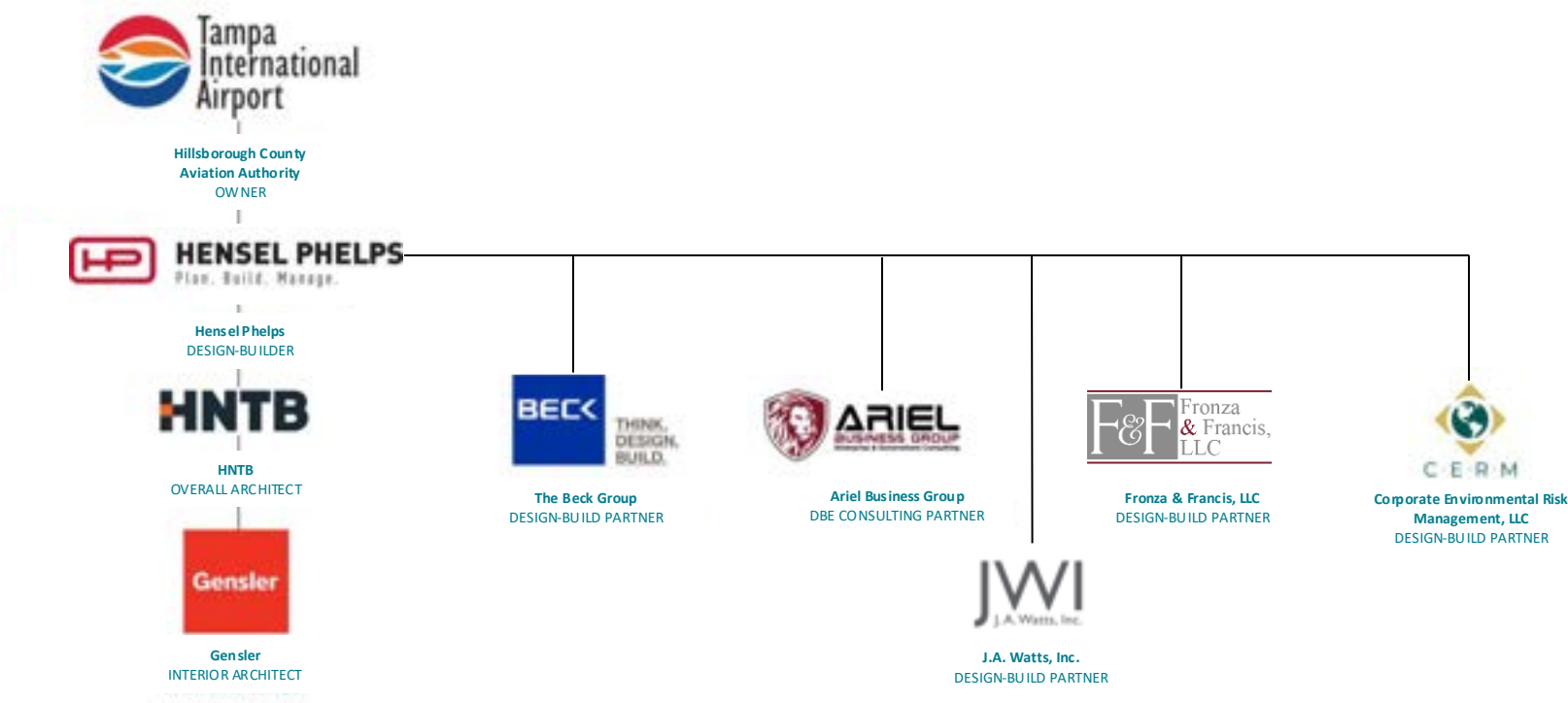

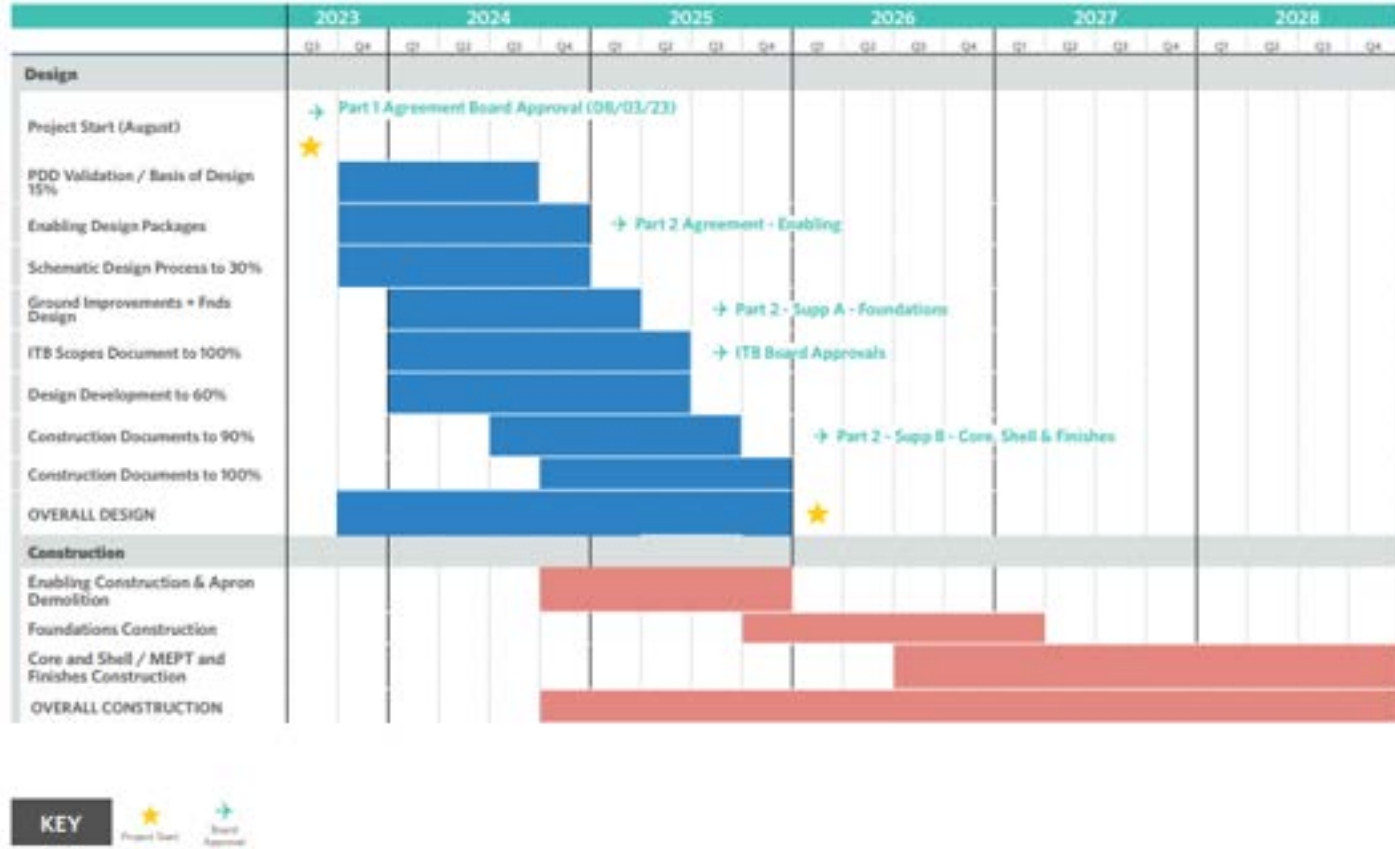

## Anticipated Bid Package Schedule:

- Bid Package Issuance – May 2025
- Contract Award – August 2025
- Commence Work – Fall of 2025



## Interested Vendors Registration

- Compass is a comprehensive platform for coordinating Interested Vendors and Subcontractor Prequalification.
- In order to register with Hensel Phelps, subcontractors **must scan and register using the QR Code to begin the process.**

## Interested Vendors Registration

- If the vendor has an account with Compass, they will automatically be added to the Interested Vendors list by logging in using the link.
- If the vendor DOES NOT have an account, they will be directed to setup an account with Compass. Using the link will automatically attach you to this project.



# Interested Vendors Registration

- Prequalification Evaluation:
  - Used for Sorting and Identifying Vendors.
  - Financial information must be shared to Hensel Phelps via Compass.



# Interested Vendors Registration

- Bonding Requirements
  - Subcontractor must submit bonding capability information through Compass.
  - All subcontracts over \$100,000 will require payment and performance bonds.
- DBE Requirements
  - If the subcontractor identifies as DBE, they must submit documentation via Compass.
  - If firms do not submit adequate documentation, they cannot identify as DBE.
